CMTA Group Workers' Compensation Safety Requirements

Injury Illness and Prevention Program (IIPP)

Each member will maintain an active IIPP that is updated on a regular and complies with Labor Code 6401.7.

Safety Management

Each member company employs an individual who is designated as being responsible for overseeing workplace safety.

Loss Prevention Plan

Each member company has a comprehensive loss prevention plan or with the help of CMTA's safety support we will establish a loss prevention plan including objectives and activities to achieve those objectives.

Cal-OSHA Compliance

Each member company recognizes the critical component of maintaining a safe work environment which includes compliance with Cal-OSHA requirements. Each member company will work with CMTA to ensure their on-going compliance with Cal-OSHA regulatory standards and procedural requirements, including accessing the OSHA consultation unit.

Accident Investigation

Each member company will recognize that a key to accident prevention is a clear understanding of accident causation factors. Each member company agrees to investigate all work related accidents at their facility and make use of CMTA resources to better understand the relationship between loss exposures to work related injuries and the causes of industrial accidents.

Accident Analysis

Each member company will recognize that a key to accident prevention is a comprehensive analysis work related accidents. Each member company will make use of CMTA resources to identify the root, direct and indirect causes of industrial accidents at member facilities.

Safety Inspections

Each member company will conduct their own facility wide safety inspections on a regular basis and make use of CMTA operation and safety inspection products and resources.

Training

Each member company will implement safety training based on inspections and accident investigations to ensure employees can complete their responsibilities and avoid work related injuries. Safety practices will be a fundamental part of all employee training.

Communication

Safety practices and general health information will be a routine component of all company communications such as newsletters, staff meetings and bulletins.

Return To Work Practices

Each member company will implement and maintain a return to work program, returning all eligible employees to modified or alternate jobs during the healing period following an injury.
