CMTA advocates for California policies that assist manufacturers and their employees. As the leading voice for California manufacturers, CMTA promotes industry interests that allow the sector to remain competitive.

Our Impact in the Capitol

The California Legislature introduces thousands of legislative proposals during each annual session. CMTA prioritizes engagement and tracking for nearly 500 proposals impactful to the manufacturing sector every year.

We prioritize bills as **Makers** or **Breakers**, so our members can quickly digest our priorities for them.

Employment Training Funds & Certification Program

CMTA members receive funds for training employees through our partnership with the Employment Training Panel (ETP).

Reimbursement for trainings you're already doing.

ETP is a State of California agency that provides up to \$75 million in job training funds annually to employers throughout the state. CMTA holds the contract with ETP instead of your company, and this makes paperwork a breeze.



As a member, your company can be eligible to get started training in as little as one week, and CMTA has a database that will track all of your training electronically. We assist you with all supervisors, hourly workers, etc. – ALL aspects of the administration of the contract.

I cannot speak to a better trade association to be part of than CMTA. Especially as a California company, we don't have enough people pushing positive policy for us. Great group of companies, great group of people, and they've been able to really move the needle in the Capitol.

Financially, I recoup my costs every year through the training funds that are available. I generally tell people it's the best investment I make every year both politically and financially!

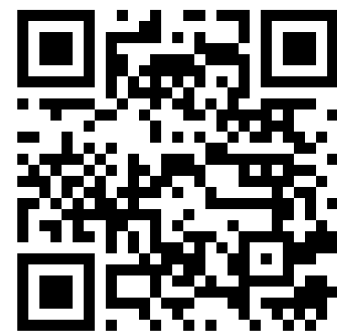
