CMTA Committees

CMTA's policy committees are the heart of our advocacy efforts. Members of our committees lend their years of manufacturing expertise to CMTA staff to provide industry-specific insight on current legislation and regulations.

Each committee is chaired by a CMTA member, meets once a month, receives regular updates and requests for CMTA member feedback, and provides members with opportunities to further participate in shaping California's industrial policy. This support from our committees is essential to our ability to educate policymakers and provide the most impact for our members.

Government Relations Committee

All CMTA members are members of our Government Relations Committee. This group functions as a hub for information from all other policy committees and provides guidance on organization-wide policy efforts.

Policy Committees

Economic Development: Advocates for growth-oriented changes to California's tax, regulatory, and legal systems to attract manufacturing investment and create jobs.

Issues include: Incentives, infrastructure, tax reform, regulatory oversight, and California's legal system.

Energy: Promotes reliable and affordable access to energy for industrial consumers. *Issues include:*

Alternative energy requirements, carbon emission, PUC oversight, and other energy mandates.

Environmental Impact: Supports science-based, economically feasible environmental legislation and regulation that is focused on ensuring compliance rather than seeking punitive enforcement.

Issues include: Recycling, packaging, water quality, carbon emissions, and other environmental impacts.

Labor: Works to resolve labor workforce issues without compromising California manufacturers' competitiveness.

Issues include: Workforce development, workers' compensation reform, health and safety, mandatory rest and leave policies, labor litigation, and other employer mandates.

Aerospace & Defense Alliance of CA: Addresses policy issues affecting the aerospace and defense industries.

Issues include: Environmental stewardship, diversity, workforce development, military and veterans affair.
